**Called to order:** 6:05 PM

Judy Simpson introduced Megan Tarby, down town business owner. Ms. Tarby has volunteered to produce a Burlesque Show at the Strand Theater in June 2011, to raise funds for Strand Renovations. Although it is only in the planning stages, she has a choreographer, caterer and make-up and costume people on board. Show will last approx. 2 to 2 1/2 hrs. and depending on how well ticket sales go, it may play more than one show. All proceeds will go to the Renovation Fund. Ms Tarby will contact Geri Swinik to secure a schedule for rehearsals and availability of small back room behind the stage.

Kim Osgood reported that Jimmie Tzepois would like to hold another wine tasting fund raiser this winter. Committee was very grateful for the support of the downtown merchants. Kim will follow-up contact with Jim.

**Strand Report:** No report

Kim Osgood reported that the cleaning seemed to be going well. Had not received any complaints. The Committee will send a letter to Geri Swinik, theater manager and request a list of fees and charges that she uses as rental costs. The Commission would like to have an actual cost sheet for different organizations, days of the week and different event rental fees.

Members of the Committee will begin to catalog movie posters for eventual sale at the Auction House or eBay.

Linda Bellavance reported to the Commission that she was in contact with Charlie Corrente regarding a Star Wars Marathon at the Strand in April 2011. He will be able to supply us with members of the Star Wars fan Club in complete costume to attend the marathon and intermingle with movie goers. 3 movies to be played back to back during a 1 day period. Starting at approx. 2:00 pm and running through approx. 11:00pm. Ticket costs to be discussed at a later date. Mr. Corrente will be invited to the January meeting to give the Commission a presentation.

**Chairman's Report:** Chairman Simpson reported that First Saturday had gone well, there was a very large turn-out, stores were full and streets were busy. Santa's arrival was a bit disorganized and steps will be taken next year to bring a little more organization to the chaos! It was suggested that Santa come in on the 6:30 train to alleviate the large crowds on Main Street during the height of the shoppers evening. This way families only interested in seeing Santa will have come and gone by 7:00 and free up parking for the shoppers and folks coming to see the Carolers. The Carolers will not attend the train arrival next year, keeping to the shops and sidewalks at upper Bank Street during that time. It was reported to the Commission that a small problem had arisen during the event, as a store Santa went out to stand across the street from the train in full view of children who were seeing 2 Santa's at the same time! Several parents were very angry and spoke to the store Santa about getting out of view because children would become very confused. Chairman Simpson will speak to store owner about the confusion.
