<u>Treasure's Report:</u> Treasurer Priscilla Altorelli reported that a \$25.00 donation to the Save Our Strand account had been received by the family of Francis Gauvin who was the first projectionist at the Strand Theater. Balance in that account to date is <u>\$2,554.00</u>

Balance in Culture and Arts account to date is \$574.52

The following transfers and payments have been made:

Donation of \$345.00 was made by an anonymous donor to cover the cost of additional brackets for the flags hanging downtown.

<u>Chairman's Report:</u> Judy Simpson has been working with First Selectman Paul Roy to secure Grants for the Strand Theater. He is working on 2 separate grants hoping to secure funds to start renovations. An estimate was presented to Geri for seat replacement at a cost of approx. <u>\$37,065.00</u>.

**Concert Series:** Larry Ace did a great job at the June Block Dance.

John Banker's contracts have been signed and returned for summer Recreation Dept performance.

Navy Band's date has been secured as much as can be.

<u>Founder's Day:</u> Chairman Simpson reported that the Founder's Day event was a tremendous success and the entertainment portion of the day went smoothly. American Hapkido, the Seymour Middle School Band and Chorus and John Banker's 2 hour concert were all well received. Discussion was held regarding only having paid performers next year to avoid the last minute cancellation of groups as was experienced this year. Plans to hire strolling entertainment through-out the day was also discussed rather than stationary performances.
