Strand Theater

Contracts: Theater Manager Jeri Swinik reported to the Board the following:

Sunday, June 15, 2008 the Strand Theater will be hosting a "Hungarian Show Revolution", with approx. 500 people in attendance. She has ordered extra refreshments for the concession stand and contacted Sgt. Paul Sadkowski from the Seymour Police Dept. regarding the parking. She also requested that the flowers in the 2 planters outside the Theater be replaced, as the flowers that were in them were very small and not thriving.

She will start to leave the trash out on Mondays for the Town Janitors to pick up each week.

She informed the Commission that John Geloso, the Strand's projectionist, had been hurt in an automobile accident and would be having surgery on his hand. He will be unable to work for a time and she is in the process of contacting other projectionists to cover while he is out. If she has no luck, Judy Simpson suggested that she contact Shelton High School's Theater Dept., as they might know of someone she could hire temporarily.

SONCCA's contract was disgusted and it was realized that no times were mentioned for the rental of the theater on the 30^{th} of July. Linda Bellavance will send the Executive Director, Arlene Swatson, a letter and ask her to contact Jeri regarding their rental agreement. It did seem that a miscommunication was involved with this particular rental and the Commission assured Jeri that it would not book contracts and all inquiries would be sent directly to her.

Joelle Anderson from J&J Gardens was invited into the meeting to question her about changing the flowers in front of the Strand. She will replace the existing flowers and return the pots to the Strand on Saturday. She reported to the Commission that she was there to replace the dead flowers in the 2 large barrels in front of Town Hall that had died due to lack of watering.

It was also reported to the Board members that an article about the Strand would be in the October 2008 issue of the publication, MARQUEE. This magazine recognizes historical movie theaters around the country. She will be sending pictures of both the inside and outside of the Movie Theater.

Minutes / Secretary's Report: Linda Bellavance stated that she had spoken with Joelle Anderson and told her to replace the dead flowers in the 2 large barrels in front of Town Hall, she also stated that she would write a letter to the Merchants Assoc. requesting them to water the containers on the four corners of Bank and First Street.

It was mentioned to the members of the commission that the flags hanging downtown for the Memorial Day parade where from the same company she had gone to the month before. Explaining that the flags from the Art Contest would be the same size and material.

She reported that a letter had been sent to Dennis Rozum requesting the cleaning of the Park every Friday for the summer Concert Series. It was also noted that he was requested
