Al Yagovane informed the Commission that he intends to revive the Broad Street Park Project. He has met with First Selectman Paul Roy, together with Michael H. Horbal to discuss their vision for the park. The goal is to make the Broad Street Park an attractive entrance to the Town of Seymour, a point of reference that will encourage residents and visitors to enjoy the beautiful, currently underutilized, park. The park would get a facelift of about \$20,000 with new lighting and new brick work. Labor would be donated by various companies. Due to the state of the economy the cost of the project has remained the same. Mr. Yagovane is once again asking EDC to endorse the project.

Various members expressed the desire to see a detailed plan of the renovation before taking any action. Mr. Yagovane was encouraged to go before the Board of Selectmen and come back next month with a detailed plan. It was suggested Mr. Yagovane seek the support of the community and of residents in Town by selling bricks or asking to endorse lamps or benches. The Commission also suggested applying for funds from The Katherine Mathie's Foundation. The Board once again is in full support of the project and willing to allocate some funds to help it move forward.

State Representative Theresa Conroy informed the commission she will be working on the following projects in 2010:

- ♣ Antique District Signs in conjunction with Senator Kane
- Main Street encouraging the State to resurface Main Street
- ♣ Seymour Fall the Tingue Fish Bypass project is scheduled to start on time

- Housatonic Wire/Seymour Lumber Project EPA applications and funds are on schedule. Working in conjunction with VCOG to fine tune a few matters.
- ← Coordinate times on all lights on Route 67 roads sensors need to be replaced. The project will start as soon as the weather warms up.
