### ITEM # 5 - ED Director Report

- Two potential parties interested in a parcel up at the industrial park. Working closely to assist in the process.
- Housatonic Wire Co. - Alex Budzinski is looking to sell. Asking price \$1.6M for 4.5 acres. Have contacted Haynes as possible buyer. Discussed vision for the lot: medical offices, nice retail boutiques and restaurant with upper deck overlooking the falls. Focus on capitalizing on the location. Contact culinary schools to see if any graduates are interested in opening a restaurant.
- Both CVS and Walgreen's Projects still awaiting DOT approval.

- Meeting with owner of parcel of land located on Route 67 and Cogwheel. Will discuss plans to develop the parcel.
- Daddio property on Derby Avenue is available for sale. Asking price is \$7 million for 67 acres. The site needs to be excavated before it can be developed and estimated cost is to prep the site is between \$25-40 million.
- Town is still in court with Tri-Town Plaza over the assessment. According to owner Ron Spector he is actively pursuing to rent the plaza.
- Seymour Lumber is available for development. Owner Tom Tkacz wants to keep the 1 acre property in the family. Possibility to develop the site with medical offices.
- Second parcel at Starbucks Plaza available for development.
- Carwash project on Derby Avenue is no longer underway.
