Answering the Roll Call were Commissioners Dota, Bellucci and White. Also present Executive Director David Keyser, Deputy Director Donna DeSantis, Attorney Gregory J. Stamos and Recording Clerk Keesha Davis.

> Public Session

> Previous Minutes

Chairperson White introduced the previous meeting minutes of the 920th Regular Meeting held on January 9th, 2013. Chairperson White made several corrections to named motions and seconds to motions correcting the names.

Commissioner Bellucci motioned to accept the minutes of the 920th Regular Meeting as amended to correct the persons and the motions. Commissioner Dota seconded the motion. Chairperson White acknowledged the motion and its second and asked all in favor of the motion to vote aye. Voting aye were Commissioners Dota and White. Commissioner Bellucci abstained from voting because he was not present at the 920th meeting. Chairperson White declared the motion carried and the minutes accepted as presented.

> Bills & Communication

Chairperson White introduced the Bills. (See Exhibit I)

After detailed discussion, review and questions Commissioner Dota motioned to approve the bills as presented and authorize payment of the bills. Commissioner Bellucci seconded the motion. Chairperson White acknowledged the motion and its second and asked all those in favor of the motion to signify by voting aye. Voting aye were Commissioners Bellucci, Dota, and White. Chairperson White declared the motion carried and the Bills approved for payment as presented.

MINUTES

The Executive Director reviewed a correspondence from HUD's Fair Housing and Equal Opportunity division.

Executive Director David Keyser reviewed the letter in regards to a Housing Discrimination report. Fine v. Seymour Housing Authority. A complaint was made stating during the initial application process there may have been some discrimination. The complaint was acknowledged and the Investigation was completed by the Dept. of Housing and Urban Development.

Based on the evidence obtained, HUD determined the evidence presented showed no reasonable cause exists to believe that a discriminatory housing practice has occurred. The complaint was hereby dismissed.

Recommendation was made by Attorney Stamos to have staff keep a phone log. The Executive Director stated that he has completed much follow up and training relative to phone inquiries about applications. No judgments or comments regarding eligibility will be made by staff to applicants on the phone. He stated that he trained the staff to respond that unless we have a written application, we cannot respond to questions about eligibility.

Committee had no questions or comments on judgment.

> Executive Director's Report

Chairperson White introduced the Executive Director's Report.

Executive Director Keyser reviewed occupancy for the four properties.

He discussed the backflow preventers being installed in Smithfield Gardens and Callahan House.

He discussed the annual recertification process that has begun. He stated that we are in the data collection phase. All tenant information is due by February 15, 2013. Those residents who do not comply with that date will be sent a pre-termination notice.

Callahan house received a few noise complaints. Noted compliants has been referred to black watch for follow up.
