TREASURER'S REPORT: The Treasurer's Report was accepted. Addendum was handed out regarding transfer of funds within endowment budget line due to Water line being reduced. In previous budgets the library had covered the cost for flushing of the water hydrant on library property and for inspection and maintenance of the backflow system. Town funds in the budget for the fire marshal are now covering this. Amount of \$1,337.00 is available from the Water line. There will be a transfer of \$215.00 to newspapers and \$685.00 to books, leaving \$437.00 in the Water line. Water bills average \$75.00 per month.

LIBRARIAN'S REPORT: First Selectman Paul Roy informed Carol of the decision to apply for grants for the painting of the trim on the outside of the library and replacing the two rooftop cooling units. Christine Battis has applied to the Community Foundation of Greater New Haven for \$15,000 for the paint project and will be applying to the Matthies Foundation for the AC installation.

Carol Ralston, Library Director, has submitted a grant for the Kindergarten Reception to be held in August. She will keep the Board apprised when any of these grants have been approved.

There was some speculation about the number of programs Seymour has in comparison to other local libraries. It seems the program listings seem longer for the other local libraries in the Valley Gazette. Conjecture is that the libraries are listed alphabetically, therefore Seymour's programs have only listings for two weeks, while the other libraries have the entire month of programs listed. Carol will approach the contact at the Valley Gazette about this.
