## Seymour Public Library Board of Directors REGULAR MEETING MINUTES January 20, 2010

**CALL TO ORDER** convened at 7:00 p.m. with pledge of allegiance led by Diane Sosnovich.

**APPROVAL OF MINUTES** from December 16, 2010 meeting was granted without any additions/corrections.

**TREASURER'S REPORT:** The Treasurer's Report was accepted with no discussion.

**LIBRARIAN'S REPORT:** Letter to Board from Carol Ralston, Head Librarian, was read and discussed. Carol informed the board that the revenue from the Wooster Trust would be \$4,100 beginning in January 2011 through December 2011.

A recommendation to begin a new budget line titled "Unbudgeted Funds" be added with monthly funds of \$235.00 deposited until the creation of FY2012/13 budget. This will allow funds to be used for small repairs to the buildings such as repairing the chimney.

A second quote to paint the trim on the outside of the library was received from CertaPro Painters, significantly lower than the original quote from a local contractor. This will be passed on to the town for consideration. There are continuing problems of leakage in the ceiling of the portico and water damage to the fascia near the damaged drainpipe. Hopefully, the cause of this will be determined and fixed in the spring, prior to painting the trim.

Robert Potash mentioned noticing water running down the bricks on the left outside entrance. Carol will check on this.

**UNFINISHED BUSINESS:** Carol Ralston, Head Librarian and Pauline Lounsbury, Chairperson of Library Board, met with First Selectman Paul Roy, Finance Director Doug Thomas and Assistant Director of Finance, Anthony Caserta on January 13, 2011. Carol outlined the Library's budget for FY2011/12. Carol will keep the Board apprised of the next meeting with the Finance Board.

Motion was made to create new budget line for the Wooster Trust Fund monies as previously discussed.
