## 2. Site Plan, Regional Water Authority, 151 Roosevelt Drive

Darleen Buttrick was present for the applicant and stated that they are looking for approval of their well field improvement project. The Regional Water Authority purchased Birmingham Utilities in January 2008 and part of the purchase was the Seymour well field. They did an evaluation of all electrical equipment on site and determined that all was below the 100 year flood elevation. The first phase is basically to bring new equipment and it will be above the 100 year flood elevation. There will be a 11 x 15 foot buildign addition on the north end of the chemical building and a new main power distribution panel to supply power to all well houses. This will have an automatic transfer switch which is now manual. They will be replacing all wiring and conduits to all well houses. A silt fence will be installed from the main area to Housatonic River.

Chm. Strumello asked how long the project will take to complete and Ms. Buttrick stated that it should be 4 to 5 months. Mr. Looker stated that the application was referred to the Aquifer Protection Agency and it was approved by them.
