Chm. Strumello read the proposed text change and stated that it is basically to allow detached single family dwellings in MF zone. Mr. Looker stated that the . purpose of the MF District is to provide housing units for small families. He stated that there is only one other parcel zoned MF that has not been developed and applications for that parcel were denied. He was concerned that a developer could put all single family homes in. He stated that the Board may want to consider limiting the size of bedroom or some type of proportion. Chm. Strumello asked Mr. Looker to write something up for the Commission to review with different scenarios regarding this proposed text change. Mr. Looker indicated that the applicant was opposed to limiting it to two bedrooms.

Strumello stated that he is within his rights to remove sand and manure. He stated that the last time he was at the site was two weeks ago and nothing was going on there. She asked if they have permits to do excavation and Chm. Strumello stated that the property has not been transferred and it is still in Mr. Crotta's name.

Mike Horbal, 52 Main Street, Seymour asked that the bond reduction request for Nichelmine Brook be looked at next month and have the town engineer review the request.
