#### Boys and Girls Club Update-

First Selectman stated that on 12/2 the Boys&Girls club will have a soft opening by transferring the Seymour kids that are currently enrolled in Shelton. A full start will for everyone will be on 1/2/14. First selectman Kurt Miller also stated that the Boys & Girls club is willing to advertise any recreation programs. The Boys & Girls club is also willing to run the Cougar's Den program fully. It would be a similar set up with the exception that it would be every week. The café is being completely re done. Recreation and Senior Center will have access to the café also. Also stated that the gym with be vacated at 5:30 pm during basketball season. On site coordination will be available.

First Selectmen Kurt Miller stated that the town is in the process of selling Lopresti School and any money taken in will be put in the recreation building.

First Selectmen Miller stated that he takes full responsibility for the lack of communication concerning the Boys & Girls club and the Recreation Commission. It wasn't his intention to exclude the Board. He saw it as a benefit to the department.
