MINUTES

Seymour Technology Committee

Special Meeting/Informational Meeting
Friday, February 3, 2012 @ 10.00AM
(Moved to) Flaherty Room/Seymour Town Hall, Seymour

In attendance: Jason Weaving, Joe Matusovich, Evan Islam, Jim Cassanelli, & George Zapherson

1. Call meeting to order.

Meeting was called to order by Chair, Jason Weaving at 10:08AM.

2. Pledge of Allegiance.

Everyone salutes the flag and says the Pledge of Allegiance.

- 3. Discussion on Town server status and possible future plans.
- Joe explained that Jason had called a special meeting, and that he had invited Jim and George to brief Jason and Evan on the Town's network.
- Jim began by explaining the "Seymour Network Infrastructure Overview Diagram" (see attached), and explained that the diagram does not show the physical servers at the Police Department.
 - Town Hall is shown on the flow chart, which gives a basic layout to show it in a virtualized environment.
 - Jim explained that we are now moving from a production environment to a virtual environment and that we are almost 100% virtualized.
 - The biggest issue we face is the lack of funding, and we are making progress with what we have.
- Joe asked where, within the network setup, the web server is located.
 - Jim explained that the web server is located on the VRT server and can be copied over.
- Evan asked whether the server is backed up at the Police Department.
 - Jim explained that the two servers are identical, that there are two new servers, that host machines are identical and running on Windows 2008. Everything is being kept compatible across the network.
- Joe explained that the backups are kept in mirrored copies (the financial system, data).
 There is a tape back-up system in place with 400GB a piece.
- Jim explained that server backups are done every night.
- The consensus with the Technology Committee was that there is an irregular tape backup schedule and that we are lacking the time and staffing to do taped backups.
- Jason explained that First Selectman, Kurt Miller, had put in a line item of \$100,000 for Technology.
- Jim explained that that figure was not enough to cover equipment breakdowns, business applications, software costs, etc., as well as to build a website. He also raised the

question as to whether the line item includes just Town Hall or does it include the Police Department, Community Center, or other areas?

- Jason asked Jim for a rough estimate on infrastructure costs:
 - Jim estimated that it could be between \$25k-30,000 for hardware, \$15k-20,000 for software, which does not include other costs such as maintenance.
- Joe explained that the Police Department does not have a line item for Technology.
 Though, he said that as new equipment comes in, maintenance costs come down. He also explained that the Police Department is the only site with a working generator.
- Jim stressed that we (collectively) need to look at the Town at the big picture.
- Jim explained that there is currently a project in place for the Police Department. Data from the Town Hall is sent to the Police Department bi-weekly for mailboxes, and database/files are done nightly. There are virtual machines at both the Police Department and Town Hall.
 - During Phase 2, all servers (VHD) will be replicated on a schedule in both places (the Police Department and Town Hall).
- Jason asked how much data is used on both servers?
 - Jim explained that they can both (together) hold 1TB.
- Jason asked Jim his opinion about adding an additional layer of backup via a remote/virtual environment, such as a cloud server through a service like Rackspace.
- Jim explained that there can never be too many backups; however, he said that rather in addition to, he would suggest a co-location situation because of bandwidth and server space.
- Joe suggested areas like Great Hill Fire Department or the schools on the 'Hill.'
- Jim explained that in those locations we would get away from the 'flood plane issue,' it would be more cost effective since we would not be using a remote/virtual environment like Rackspace, since at a co-location we would be utilizing Comcast.
- Joe explained that if a co-location were at Great Hill Fire Department, we would have use of a generator. Also, as far as disaster recovery, the area was used as a command center. If we were to use this area it can also be on the network.
- Jim said that rather than using a remote/virtual environment like Rackspace, Great Hill Fire Department is less costly and they already have the need for the Comcast line.

4. Other business.

- Jason asked who the current registrar of the Town's website is, where it is hosted, and if we can get the FTP login information.
 - Jim explained that the Town's domain is registered through Network Solutions. The site is hosted on the Town's servers and there is no FTP login.
- Evan asked whether we could host the Town website offsite.
 - The consensus was that yes, the site could be hosted offsite via an online hosting service.

5. Public comment.

No public comment.

6. Adjournment.


