Minutes of the Seymour WPCA special meeting for July
8th, 2008 at 6:00 pm –at the Sewer Facility

Members Present: John Fanotto, Stephen Chucta, Lou DeBarber, and Jon Livolsi
(Charles Bellavance came in at 6:25pm)

Others present: Tony Bellao, Project Manager Veolia Water Jon Marro, Atty. Richard Bruchal, Jim Galligan and other members of the public.

Jon Livolsi called the meeting to order at 6:16pm.

The pledge of allegiance was given.

Stephen Chucta made a motion, Lou DeBarber 2nd to approve the June 10th 2008 Minutes. Motion did not pass; 2 yes, 2 abstentions- this will appear on next month's agenda.

Veolia Water

Operations- Tony Bellao reported the plant and pump stations underwent several power "bumps". Also, the CTDEP conducted an air quality inspection, and the sewer plant passed. The Nickelmine pump station will be monitored for grease buildup, even though there is only 10-12 houses connected to it.

Income report- Jon Marro submitted this to the board.

Stephen Chucta commented on the physical condition of the older white box van, and wants this replaced. Discussion ensued about the age of the van, and Tony Bellao was directed to get 3 quotes on a replacement for next meeting.

Financial report – this was submitted to the board.

Stephen Chucta made a motion, Jon Livolsi 2nd, to pay the above invoices. Motion passed 4-0.

Legal Report- Atty. Richard Bruchal reported that the pending litigation with G&G Seymour LLC is proceeding.

Jon Livolsi asked about delinquent accounts, and Jon Marro was directed to have a list of persons who have not set up payment agreements for next meeting.

Engineering Report- Jim Galligan reported on the inspections on Chatfield Farms, O&M manual final draft, and GIS mapping updating.

Public Comment-

John Fanotto asked if the other members of the WPCA had read and acknowledged last month's (June 10th, 2008) minutes. Atty. Bruchal was asked (by board members) if Town Hall officials had understood that the sewer use bills were not refunded and that they should cap and plug the sewer lines from the public parks if they did not want any future sewer use bills. Discussion ensued on how many years the estimated water bills (which the sewer use bills are based on) that were paid seemingly without question.

Stephen Chucta made a motion, Lou DeBarber 2nd, to adjourn the meeting. Motion passed 5-0. Meeting ended 6:45pm.

OPERATIONS

The Seymour WPCA remained in compliance in each of the monitoring parameters through the month of June, 2008. Average data is as follows:

BOD-100% Removal (Effluent average=6MG/L)

TSS-100% removal (effluent average=8MG/L)

Flow 1.04 MGD

MAINTENANCE

Plant repair and maintenance items include the following:

- Changed contact tanks from East to West
- Had power bumps at Main Plant due to storms
- Cleaned South Clarifier
- Cleaned Service Water Pit
- Replaced drive on belt press
- Cut grass and did cut weeds in main plant
- Cleaned South Clarifier
- Cleaned Final Effluent Sample P
- Call in for Hypo due to storm
- Spray for weeds in Main Plant
- Removed weeds on Green House

COLLECTION SYSTEM

- Checked all pump stations
- Power failures at all pump stations due to storms
- Cut grass at all pump stations
- Grit North and South Stations
- Corrected call box at Glen Circle Pump Station went to touch tone not pulse
- Cleaned grease build up off floats at Nicklemine Pump Station

SAFETY

- No safety violations for June
