# Minutes of the Seymour WPCA special meeting for April 1<sup>st</sup> 2008 at 6:00 pm –at the Sewer Facility

Members Present: John Fanotto, Stephen Chucta, and Jon Livolsi.

Members not Present: Lou DeBarber and Charles Bellavance.

Others present: Tony Bellao, Project Manager Veolia Water Jon Marro, Atty. Richard Bruchal, and other members of the public.

John Fanotto called the meeting to order at 6:10pm

The pledge of allegiance was given.

**Stephen Chucta** made a motion, Jon Livolsi 2<sup>nd</sup>, to accept the March 5<sup>th</sup> 2008 minutes. Motion passed 3-0.

John & Debra McKeown- 19 Patrick Drive- Mr. McKeown presented to the board a request for a payoff amount of his sewer assessment and to clear up the status of the assessment. Mr. McKeown was not sure if the 1998 assessment was truly his, as some of the houses in the subdivision where he lives, were paid by the builder Haynes Construction. The board & Atty. Richard Bruchal recommended that Mr. McKeown research his closing statement/papers and contact his closing attorney to see if the details of such included his paying of the assessment or the builder paying the assessment. Mr. McKeown offered to pay \$4,500 (the original assessment) and have all the interest waived. John Fanotto and the board responded that they could not do this under state statute. The board recommended to the homeowner to "catch up" in payments and research his closing statements.

#### Veolia Water report-

Tony Bellao reported on the plant and maintenance-

Of note; 11 Moss Avenue- sewer backup, which poured water into homeowner's basement, occurred and cleanup was affected to the basement. Rocks that were in the sewer line could be the culprit of the backup. The homeowner submitted a letter to the board asking for payment to compensate for a replaced carpet and a number of other objects/matters; for a total cost about \$1200 plus unspecified amounts. After some discussion, the board decided to give \$1,000. Jon Livolsi made a motion, Stephen

Chucta 2<sup>nd</sup>, to offer \$1,000 subject to signing a release from Atty. Bruchal. Motion passed 3-0.

Tony Bellao reported that CTDEP will give \$14,900 as a nitrogen removal credit to Seymour WPCA.

Income Report- Jon Marro submitted this to the board.

Jon Marro was directed to have a budget workshop for May's agenda.

To discuss ongoing litigation, **Jon Livolsi** made a motion, Stephen Chucta 2<sup>nd</sup>, to go into executive session at 6:58pm. Motion passed 3-0.

At 7:03pm, **Jon Livolsi** made a motion, Stephen Chucta 2<sup>nd</sup>, to exit from executive session, no motions were made, and no votes were taken. Motion passed 3-0.

Engineering report- Jim Galligan was not present.

Public Comment- Stephen Chucta thanked the board members and Veolia Water for their support during the recent passing of his wife

Stephen Chucta made a motion, Jon Livolsi  $2^{nd}$ , to adjourn the meeting at 7:07pm. Motion passed 3-0.


