John Fanotto, 45 North Street, Seymour was present for the applicant. He stated that this lot is a little over a half acre and was created in 1955 prior to zoning. They are requesting a side yard variance from 25' to 8'. The property is located in the R-40 zone. They are proposing a single car garage which will be located at the end of the driveway. Mr. Fanotto presented a letter from John and Cheryl Gillick, 6 Tibbets Road, the closest neighbor stating that they were in favor of the application. He also stated that this is the best location for the garage and it will be one story to match the house. Mr. Looker stated that it is not unreasonable. There was no public comment on the application.

He stated that they have permits from DEP, Army Corps of Engineers, Inland-Wetlands and ZBA. He stated that they are seeking renewal of their permit so that they can continue with their work. Mr. Looker stated that the project has been ongoing for about 12 years and he inspects it every year and has never had any problems there. He stated that it is monitored by DEP and he would recommend that the Commission consider extending the renewal for as long as the DEP approval which is through 2019 or Army Corps of Engineers which is through 2017 as long as it is approved by Inland Wetlands. There was no public comment on the application.
