Public Works Directors Report. Robert Koskelowski Jr reported that they are low on seed. 50% of the budget was spent in the last 3 months. Robert will also check on the fertilizer for the spring and get the spread sheet for the supplies for the next meeting.

Pumpkin Festival - all went well.

The restroom locks at Gary Park and Mathies Field are in working order.

Smoke in the Valley was denied use of the restrooms at Mathies Field for storage.

Gary Park need the backstop repaired on the baseball field.

French Park batting cage need a new support bar on the fence.

Mike Horbal stated that the encroachments for utility easements at Chatfield Park and Seymour Land Trust / Legion Pool need to be completed by the attorneys, Fred Stanek and Brian Lima.

Grant money needs to be returned for the rest rooms that were not started to be built at Chatfield Park. The utility easements were approved.

Bill Wilkins will talk to Mike Horbal about the bricks for the Friends of Broad Street Park and complete the legend for brick location. Parks Chairman, Bill Paecht has contracted out the volunteer list and is still waiting for the final volunteer list from the Friends of Broad Street Park, Al Yagovane.

For Friends of Broad Street Park placed a P O for 4 gallons of stain and 46 light bulbs from Oxford Lumber. Motion to accept was made by Mike Gargano, 2nd by Gary Popielasz. All in favor.

For Friends of Broad Street Park placed a P O for 130 bags of mulch from Lowes for \$492.70. Gary Popielasz made a motion to accept, 2nd by Bill Sawicki. All in favor.

Field permit application for Pop Warner to use for Sochrins Pond on 11/5/16 or 11/6/16 from 7 AM to 7 PM with the stipulation that it was not being used. Mike Gargano will check on this. Motion to accept was made by Bill Sawicki, 2nd by Gary Popielasz. All in favor.
