"The Town of Seymour opened bids for the above referenced project on Monday, May 11, 2015. There were three bids submitted. The low bidder was Earthworks Excavating and Landscaping, Inc. with a base bid of \$741,723.00. This office has reviewed the bids and found that the bid submitted by Earthworks Excavating and Landscaping, Inc. complies with the bid documents.

Therefore, this office recommends award of the referenced projected to Earthworks Excavating and Landscaping, Inc. in the amount of \$741, 723.00, subject to the approval of the Connecticut Department of Energy and Environmental Protection.
