She stated that she spoke with someone at West Haven High School who used the WBA Group and Nafis & Young. They were happy with the end product and had minor issues. She stated that Oxford High School also used Nafis & Young and also had some minor issues but the project went well and they were happy with the outcome. She stated that Trumbull High School Athletic Director was happy with everything. She also spoke with a Board member from Old Saybrook High School who used Luke McCoy and they were very happy and stated that they were always able to get answers to any questions or concerns they had. She stated that Uxbridge High School in Massachusetts used the same company and their project was completed on time and within budget. She stated that they recommended taking more soil samples.

Mr. Hatfield stated that he spoke with the Region 19 Superintendent of School stated that he was not there for the completion of the project and they had a little trouble with the contractor. They used Milone & MacBroom and were very satisfied with them. Mr. Walsh

stated that Milone & MacBroom put on a very impressive presentation. They have a lot of credibility and experience and are a large firm.

Theresa Conroy stated that Milone & MacBroom did a great presentation. She stated that she liked how Nafis & Young would handle the project.
