The meeting was called to order at 7:30 p.m.

Storm Water Management Plan, Seymour High School, 2 Botsford Road.

Inland Wetlands Permit for a Regulated Activity, Seymour High School, 2 Botsford Road.

Mrs. Andrzejewski stated that the pond on the property drains into the Naugatuck River and asked if a general permit would be required from the DEEP. She also asked if this was reviewed by town counsel to see if that was necessary. Mr. Galligan stated that the plan was completed as if it was going to be submitted to DEEP. He stated that the way the regulation is written if a project is five acres or larger it has to go to DEEP for registration. He stated that they did not think it needs to go there as it is a small construction project between one to five acres. The jurisdiction for projects of that size are given to the municipalities. Mr. Galligan stated that there is an under drain system around the field that drains to the pond. The contractor will excavate out one area at a time and place down fabric and then move on to the next area. A system of under drains will be put in which will drain the field. On top of the under drains will be stone and this will continue across the field. There will be no stockpiling of materials. There will be two different layers of gravel materials on top of the drains. The track is pitched inward and there will be soil and erosion fencing around the entire area. The existing bleachers will be removed and that material will be taken off site. New bleachers which are handicap accessible will be installed. Mr. Galligan indicated on the map where the discus area will be moved to. Mrs. Andrzejewski asked if there are any plans to drain the area where the discus area will be removed. Mr. Galligan stated that there are no changes planned for that area.

Mr. Wetowitz asked about long term maintenance of the area and Mr. Galligan stated that the grooming machine is being purchased and the field will need to be groomed after eighty hours of practice or play. He stated that the system is designed to handle five inches of rain which is a one hundred year storm event.

Mrs. Andrzejewski about erosion controls. Mr. Galligan stated that the entire project area will have silt fencing and haybales. There will be anti-tracking pads installed. Mrs. Andrzejewski asked about the phasing of the project. Mr. Galligan stated that the majority of activity should begin once the project receives approval from this Commission and finished before the start of football season. He stated that someone

from his firm will be on site daily to monitor the project. Mrs. Andrzejewski asked about impact to the wetlands. Mr. Galligans tated that the onlya ctivity is in the upland review area with some excavation and grading.
