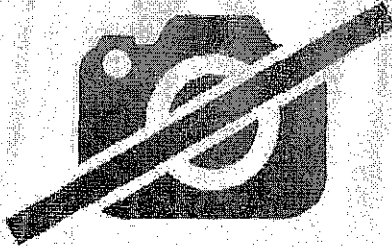

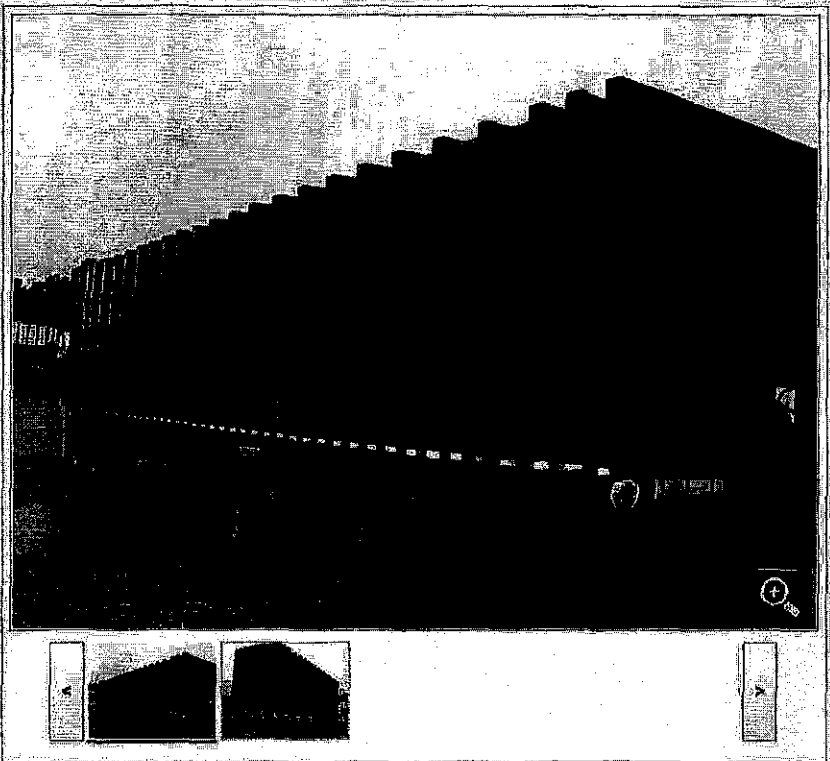

**If you have received a tax bill from a town that you DID NOT RESIDE IN OR GARAGE YOUR VEHICLE IN as of October 1, 2015, contact the Assessor to request a transfer to the Correct Town / City of residency as of October 1, 2015.**

The motor vehicle tax bill covers the period of October 1, 2015 through September 30, 2016. If a vehicle was replaced after 10/1/15 and the registration was transferred to another vehicle, this bill is still due. You will receive an automatic credit for this vehicle on a supplemental bill in January 2017. For vehicles sold, stolen, totally destroyed and the registration was not transferred to another vehicle, or if you have moved out of state, you may be eligible for a tax credit. To obtain a credit, you must furnish proof as required by the Assessor.
