> 962nd Meeting

The 962nd Meeting, a Regular Meeting of the Seymour Housing Authority, was held on June 8, 2016 at the Smithfield Gardens Assisted Living Facility, in the Multipurpose Room located at 26 Smith Street Seymour, Connecticut and was called to order at 5:48 P.M. by Chairperson White.

Answering the Roll Call were Commissioners Bellucci, Dota, Horelick, and White.

Also present was Executive Director David Keyser and Attorney Gregory Stamos.

New Business

Chairperson White acknowledged an invited guest; Jason Rieger, Assistant Administrator, Masonic Care. Chairperson White asked for a motion to change the order of the Agenda to discuss new business with Jason Rieger.

Commissioner Bellucci motioned to Change the Order of the Agenda to discuss New Business. Commissioner Horelick seconded the motion. Chairperson White acknowledged the motion and its second and asked all those in favor of the motion to signify by voting Aye. Voting Aye were Commissioners Bellucci, Dota, Horelick and White. Chairperson White declared the motion carried and New Business now open.

The Executive Director introduced Jason Rieger who explained that Masonic Care is glad to be at Smithfield Gardens. He stated that he met with the Executive Director and Deputy Director and recognized that their mission and purpose matched well with Masonic Care's Mission and felt this would be a good match.

The Executive Director also stated that he reviewed Masonic Care's operations as well as their references and based on the interviews, he and Donna DeSantis felt that Masonic Care would provide the level of Care desired for the residents of Smithfield Gardens.

Jason commented that he and Masonic Care want the best level of care for our residents which includes quality staff and a good educational system. He stated that we will benefit from Masonic Care's hiring practices and commitment to quality and caring staff. He stated if someone on his staff does not want to care for the resident's like they would

care for their own family, then the person is asked to consider if this is the right job for them.

Commissioner Bellucci asked Jason what kind of services will the Aides be participating in for the Residents.

Jason stated that the Aides will assist with showers, dressing, med reminders, queuing medications and participation in Activities among other tasks provided for in the Department of Public Health regulations.

Chairperson White and Commissioner Dota commented asked about an on-site Nursing Supervisor.

Jason stated that there will be a full time Nurse Supervisor and a Part Time Nurse as well. He stated that these two individuals will take turns being on call for weekends and nights for any problems that arise so that it will be someone familiar with the property to handle after hours' issues. He stated that there will be supervision during the day and until 9PM or 10 PM, which is what we are getting now from Utopia. He stated that the overnight people will be periodically dropped in on from time to time. He stated that the Nurses have supervisory skills and will be able to deal with any staff issues that arise.

Commissioner White asked when the expected start date was.

Jason responded that they expect to start July 1, 2016.

The Executive Director stated that early indications are that Masonic Care will be a good fit for Smithfield Gardens and that the services to the residents will be greatly improved. Masonic Care shares the same commitment to caring as we do. He stated that one year from now he is convinced we will look back and know this was a good decision.

The Commissioners thanked Jason Rieger for attendance and explanation of the change in Services.

The Executive Director informed the Board that he has again been approached by Mr. Oliwa to receive the gift of 7.43 acres of property located adjacent to Callahan House property and running all the way to New Haven Rd. The Executive Director stated that there are no development funds available, and that elderly disabled funds are very difficult to obtain because the State's priority is family housing. He stated that the Seymour Housing Authority is not in a position to pay property taxes on this property. If the gift is to be accepted, the Town of Seymour would have to agree to waive the property taxes on the property. The Executive Director stated that he proposes to write a letter to the First Selectman asking him to negotiate a deal to waive the property taxes on this proposed property until such time as it is developed and occupied for housing.

After some further brief discussion Commissioner Horelick motioned to authorize the Executive Director to write a letter to the First Selectman asking him to negotiate a deal to waive the property taxes on this proposed property until such time as it is developed and occupied for housing relative to the 7.43 acres of property located adjacent to the Callahan House. Commissioner Bellucci seconded the motion. Chairperson White acknowledged the motion and its second and asked all those in favor of the motion to signify by voting Aye. 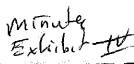
