The meeting was called to order at 7:30 p.m. by Chairman P. Wetowitz.

Public Comment

There was no one from the public wishing to speak.

Approval of Minutes, June 27, 2016

Inland Wetlands Application, Dakota Woods Garden Apartments, 20 Spring Street, Discussion and Possible Action.

Storm Water Management Application, Dakota Woods Garden Apartments, 20 Spring Street, Discussion and Possible Action.

Mr. Wetowitz stated that a letter was received from John Paul Garcia on behalf of the applicant requesting a thirty day extension of time so that they can review the revisions recommended by the town engineer.

46-100 Roosevelt Drive, Mixed Use, Vineyard and Retain Sales, Wetlands/Storm Water Management Permit, discussion and Possible Action.

Zach Georgina, Juliano Associates was present for the applicant, Tonio Marvulli. He stated that there is currently an existing driveway and gravel path on the property. The house that was there has been removed. He stated that there is a stream and also a man-made pond. There are pockets of wetlands on the site and an existing water trench. He stated that he did not see any moving water in the trench. The proposal is for a vineyard, 10,000 s.f. retain use with some apartments on the second floor of that building. There will be a tasting room and gift shop. There will also be a small ice cream kiosk which will only be accessed from the outside. There will also be a private home built on the site with some equestrian use associated with that. They are proposing to use the existing driveway for the residence and vineyard which will be

upgraded. The parking and retail use will be kept outside of the wetlands. There will be two handicap parking spaces in the upper area.

Mr. Wetowitz asked if there will be any impact to the wetlands. Mr. Georgina presented the grading plan and stated that the grades will be the same as the existing. They will not be disturbing the wetlands and any area of disturbance will be for the vineyard use. Mr. Wetowitz stated that the town engineer needs to review the plans and application. Mr. Flynn asked if there will be any irrigation devices on the site. Adam Testi stated that the trellises over the grapes will have sprinklers for watering. Mr. Wetowitz asked about the storm water management plan. Mr. Georgina stated that he met with the town engineer and was told that they could tie into the existing storm water plan. Mr. Wetowitz stated that the Commission does not know what the storm water plan will look like. Mr. Marvuli stated that he was hoping for an approval so that he can proceed with the plans and also the planting and not miss the season.

Proposed Parking Lot, Seymour Congregational Church, 45 Broad Street, Wetlands and Storm Water Permit.

Karl Kregling representing Don Smith stated that Mr. Smith has been working with the First Selectman and the church on this project. The church has a need for more parking. They purchased three lots behind the church which they want to use for parking. There will be 1300 s.f. of impervious surface and runoff from there will go into the catch basins. There was no wetlands on the site and all activity is within the upland review area. Mr. Wetowitz stated that a letter was received from Donald Smith submitting the applications. Mr. Smith stated that both applications are for the Town and requested that the fees be waived.

Town Attorney, Presentation of Timeline and Outline for Updating Inland Wetlands Regulations and Storm Water Management Ordinance, Discussion and Possible Action.

Atty. Schellenberg stated that Atty. Marino is working on this and should have the proposed regulations at the September meeting for the Commission to review. Mr. Wetowitz stated that they can be reviewed at the next meeting and then a public hearing scheduled. The storm water management ordinance will be a recommendation to the Board of Selectmen Ordinance Committee. Mr. Wetowitz asked if the fees can be discussed at the next meeting and Atty.
