The meeting was called to order at 7:30 p.m..

1. Public Comment.

Bill Farris, 13 Spruce Brook Road, Seymour stated that the minutes from the last meeting have not been available and the public has no knowledge of what happened at that meeting..

2. Plan of Conservation and Development

Mr. Paecht stated that the Board of Selectmen has not acted on the Plan of Conservation and Development. It was tabled at their last meeting. He stated that they still need to act on this.

3. Allen Industrial Park Update.

Brian Nesteriak stated that they submitted a plan in January to install a mass volume propane tank. He stated that he was at the site and a lot of items originally approved have not been completed. He also stated that a large fill operation is going on at the site. He stated that he could not endorse the plan because there are illegal activities going on there. He stated that this application was subsequently denied without prejudice. He stated that he spoke with John Fanotto that they need to submit a plan. Mr. Fanotto had indicated that a new plan would be submitted but it has not been submitted at this time. He stated that they have not complied with the original site plan approval and it would be his recommendation that a cease and desist order be issued. He also stated that a remediation plan should be submitted. Mr. Nesteriak stated that he spoke with the Chairman of Inland Wetlands and will also speak with Town Engineer Don Smith. Mr. Lavranchuk stated that there is a lot more runoff from the site because of the filling operation that is being done there. Mr. Nesteriak stated that there has been a tremendous amount of excavation on the site.
