B. BOE Fees Analysis - Rick Belden

Mr. Belden reviewed the BOE Fees Analysis for the committee. Ms. Magri asked why this report was created and Mrs. Syriac said this was a result of a request at the last Policy Committee meeting. Mr. Putorti asked where on our budget does the in/out show. Mr. Belden said a large part of the fees collected go to line item 120 Custodial Fees to cover the custodian overtime. The overtime increases the line item and the fees reduce it. Athletic fees collected go into the school activity accounts. They go toward reducing some of the athletic costs, but do not cover everything. We pay the balance from line item 330. Ms. Harmeling asked about auditing the student accounts and Mr. Belden said there is a process in place. Student activity accounts are also used for fees collected for such things as field trips. Ms. Harmeling asked for a list of what funds go in/out of the student activity accounts.
