ITEM #5: First Selectman's Report.

- The Budget process continues to take shape. Workshops have started and the Board of Finance has begun deliberations. My budget is just about done but I am just waiting for a few last minute numbers. I will be presenting my budget on Wednesday, March 1st at 7:00 PM in the Norma Drummer Room.
- The Governor will present his budget tomorrow at noon to the state legislature. At that time we will have a better understanding of what the revenue projections on state funding will look like. We are expecting cuts but are unsure of the severity of those cuts.
- On Friday the Governor announced he will be shifting 1/3 of cost of the teacher's retirement system payments to the towns and cities. This will add 407.6 million dollars to local budgets. Each town will be responsible to pay about 10% of the salary which in Seymour's case will be 1.5 to 2 million dollars. Very little information has been provided. I will expect to hear more tomorrow. This will have a dramatic impact on the Board of Education budget.
- I met with the Board of Education to discuss the joint operations department for the town. My thoughts and ideas were well received by the members and they voted to tentatively move forward. I will be meeting with Rick Belden, Tony Caserta and Yashu Putorti to create job descriptions for final approval. I expect this to take place in March.
- Contract negations are ongoing with the Clerks and Public Works unions. We have been able to work quickly through the initial meetings. I expect to have an update as to where we stand in the beginning of March. I expect to ratify contracts hopefully at the second meeting in March.

Kurt stated that with Nicole moving up to that State legislature, she will be stepping down as Deputy First Selectman but will stay on as member of the Board of Selectmen. He thanked Nicole for her hard work and effort over the last 5 or more years. She was very engaged and involved and made Seymour proud.

ITEM #8: Discussion and take possible action regarding awarding of bid for town building architectural engineering contract.

Mike Marcinek, 6 Dahlia Lane, Chairman of the Permanent Building Committee, stated the committee had advertised for architects in December and initially got one and went back out and received 5 submissions. Upon submission they have shortlisted it to three (3) firms: Associates - out of White Plains; Ames and Whitaker – out of Southington; and Quisinbury - out of the Hartford area. He stated they interviewed with all three firms. They spent time questioning them about their approach and fees. All the fees were relatively close. They were comfortable that the scope of services was understood. They felt that Ames & Whitaker had more experience relative to this type of construction. They came prepared in the interview to a solution that they think is going to help the town to get the project done faster and quicker.

He discussed the issues with the Library, the Police Station and Town Hall that they will be working on. Al Bruno inquired if the town worked with this firm before.

Mike stated they have worked for the town before and have done a lot of municipality work.

Please find attached a proposed sample of the Town of Seymour's application for building permit and related construction and mechanical permits.

As of this time, I do not see it necessary to increase the overall fee structure that is in place for the Town of Seymour.

However due to the changes made in the CT State Building Codes adopted on October 1^{st} 2016 by the General assembly a significant increase of inspections on many areas of permit requirements has now been added for the Building Department.

An addition of a line item fee of \$10.00 (TEN dollars) for administrative services will be added to the permit application and applied to all permits that are to be issued.

This fee will help offset the increase in required inspection and administration work that has been added through the changes of the CT Building Code.
