Item #6 - Comments from the Finance Director

- Audit is almost done; they are working on the report
 - o a few notes on Library and Private Duty will include some new procedures
 - o \$750,000 surplus from last year
 - o ADP working on getting automatic entries
- Doug Thomas passed out Summary of State Budget cuts
- We will get about \$700,000 from restructuring of bonds; LoCIP grants \$213,763
- Total cuts from state is \$1,848,734 (detailed on backup sheet)
- Bill Sawicki asked Doug Thomas to find out from the Board of Education what they are planning to do to
 cut (revise) their budget in light of the cuts by the state. Bill needs to hear from someone on this. It is
 not right that the Town (side) of the budget should take the hit. Bill said he would be willing to meet
 with the First Selectman and Superintendent and Finance Director to discuss this.
- Bill Sawicki asked Doug Thomas to provide him with an excel sheet on the restructuring of the debt service. Doug can send to all information on the Standard & Poors meeting.

- Richard Demko asked if we would be using Fund Balance for the deficit. Bill Sawicki advised doing that
 as an absolute last choice. We don't want to risk dropping our bond rating. It wouldn't look good if we
 just went to Fund Balance as our first action.
- The First Selectman has asked for a 10% cut from all departments on current year budgets.

Item #8 - Charter Revision Update

- Bill Sawicki said he had made some notes for revisions on the charter.
- If anyone has any revisions, they should please bring them to the December meeting. Bill asked that we put the section # at the top of the page.
- Some of the ideas include:
 - doing away with the Town Meeting to approve the budget the elected officials should be responsible for the budget; the Town Meeting/Referendum is fine for smaller towns, but Seymour has grown
 - o voting on the budget as a whole (not separating Board of Education for a separate vote)
 - o raising the limit on transfers requiring vote from \$50,000 to \$100,000
 - o having the WPCA not oversee the water rate
- The Charter Revision Committee will invite departments to one meeting to discuss their recommendations; Bill Sawicki said that he may call a special meeting to discuss the Board of Finance recommendations to the committee so that we can present to them as a package of ideas.
