added for chipping the brush pile at the transfer station, but was not. As a result, there is no money with which to chip the pile.

Item #8:Work update

There was a discussion on the catch basins for storm drainage. It was stated that they have the vendors to clean the catch basins this year. A third of the basins will be cleaned before winter. It was stated that placards should be put on all the basins that lead to the sound. There are currently no future plans for stormwater and basin maintenance. It was stated that the road below Bungay school still needs to be milled and paved.

Sean requested an updated list for the vehicles. The director stated he would get one for him.

Item #11:Discussion on 5-year capital plan
