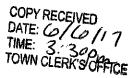
MINUTES

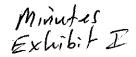
> Adjournment

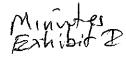

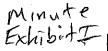

By using the HUD PHAS Management Operation formula to calculate vacancy percentage, vacancy day percentage would be calculated as follows: 80 units X 365 days = 29,200 days available; 32 days/ 29200 days available = .0010% percentage through April 30, 2017.

Beginning with July 1, 2011, HUD is using a new formula being applied to the Operating Subsidy calculation. HUD is allowing for 3% vacancy. Vacancy over the 3% will not be paid in subsidy. For example, Callahan House has: 80 units X 12 = 960 unit months available (UMA). 960 X 3% = 29 UMA or 348 days. General Information

Complaints

Callahan House

In February 2017 Marijuana was smelled in the common area on the first floor. Seymour Police Department was called. As a result, Seymour PD processed criminal action. Seymour Housing Authority issued a pre-termination notice. The Housing Court date for this case is scheduled later this month.

We had an event that involved alleged threatening situation that resulted in a resident being arrested. A Pre-termination letter was sent and we are perusing eviction proceedings.

Norman Ray House

We have not received any complaints for the month of February.

Moderate Rental

We received a complaint about bullying occurring at the bus stop involving a child being pantsed. We referred this to Seymour PD.

I have completed a selection process to replace Cody Taylor on our Maintenance Staff. I have hired Kevin Crawford. Kevin is a resident of the Moderate Rental community on Chamberlin Rd. He is a welcomed addition and started on May 1, 2017.

We terminated employment of an overnight care worker at Smithfield for willful misconduct. This position has been filled.

We began the process of the Annual Waiting List Purge. Letters went to applicants prior to May 1, 2017 for them to respond if they were still interested.

The Smoke free policy Lease addendum was drafted and we signed them with Callahan House and Ray House residents. There remain approximately 10 residents at Callahan and 3 residents at Ray House that remain to sign the addendum.

We have registered and applied for the Farmers Market Coupons.

We are cooperating with the Town Assessor to administer the Rental Rebate. We have printed out each resident's rental history for the year.

Rev. Callahan House

- All 80 Annual Inspections for 2017 have been completed in preparation for the HUD REAC inspection to take place on February 28. Work items vary by apartment most common items is caulking of windows and bathtubs, replacing countertops, and replacing bathtub strainers.
- 2016 Capital Fund Program work items have begun and are substantially complete. The smoke alarm system was upgraded and all unit smoke detectors scheduled to be replaced were replaced. The cycle painting of 10 units was also completed. We are waiting to complete the change order for replacing the smoke detectors that control the elevator operation in a fire emergency.
- HUD REAC inspection of Callahan House occurred on February 28, 2017. There were a few findings and the inspection resulted in a score of 83.
- We negotiated the 1st floor hallway carpet replacement contract with the lowest bidder,
 Olympus Construction. We received 2 bids for the job that were in excess of \$30,000. We
 recently negotiated with the low bidder and applied some value engineering and have
 arrived at a price of \$15,900 to complete the work. A notice to proceed has been issued and
 the work will begin toward the end of June 2017.
- The Town of Seymour has submitted an application to the State of Connecticut Department of Housing for a Small Cities Grant for funding to install two generators to be located at the Rev. Callahan House and the Norman Ray House. These would be back up generators to power the buildings in the event of a prolonged power outage. As part of the application, a Phase I Environmental survey was completed. The Capital Needs Assessment was updated. Bid documents were also prepared. The Town of Seymour has paid for the preparation work for the application.

Norman Ray House

- All 40 dwelling inspections were completed for 2017 in preparation for the February 28, 2017 HUD REAC Inspection.
- HUD REAC inspection of Norman Ray House occurred on February 28, 2017. There were a few findings and the inspection resulted in a score of 91.

Moderate Rental

- I will begin the annual inspections of the Moderate Rental dwelling units this month. They will be completed at a rate of 4 units per week.
- There is a rent increases scheduled for July 1, 2017. Residents will be notified on or before June
 1, 2017 that the Base rent will raise by \$10/month and the percentage of income charge will increase to 29% of income.
- We signed new Leases with Moderate Rental residents during the Recertification Process. One of the changes to the Moderate Rental Lease signing was to update the Leases with family members that turned 18 since the original Leases were signed. Another change was to update the Lease with the latest late fee schedule.
- We are planning to open the Moderate Rental Waiting List June 30, 2017.
