August 6, 2018

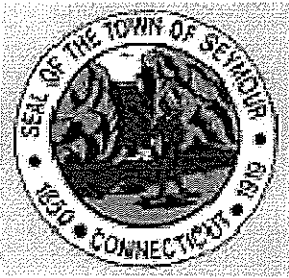

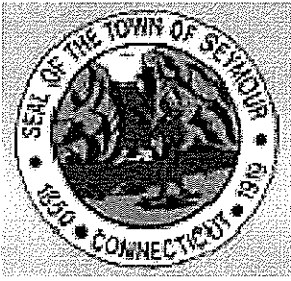
Let Al Rochelle know if anyone plans to take any FF1 or FF2 classes.

There is no need to shout into the microphones. Screaming escalates the situation.

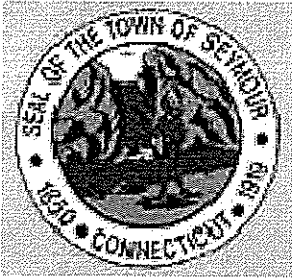
Al Rochelle suggested getting quotes for smaller tvs.
