#### DISCUSSION AND POSSIBLE ACTION

### A. Information and Recommended Action

Financial Management Summary ending January 30, 2018

Mr. Hatfield asked Mr. Belden to do an overview of the Financial Management Summary.

Mr. Belden reported the approved 2018-19 Board of Education budget was provided to the First Selectman for inclusion in the Town 2018-19 budget process. The education budget will be presented on February 7, 2018 at 7:00 pm. He said the hard freeze continues on all discretionary line items with a target of \$309,000 in bottom line savings to be returned to the Town fund balance at year end. The certified staff line item, continue to remain on track, non-certified staff line item continue to be with budget parameters with the clerical paraprofessionals reflecting a savings to be carried forward to year end. This is due to the reduction in force in December, 2017. Benefits are trending on budget. Tuition for Special Education private facilities is currently over budget due to having several new students who were outplaced in the last several months. The discretionary accounts continue to maintain a hard freeze as these funds are being used to provide the projected savings needed by the Town to offset the mid-term revenue reduction.
