VII. <u>REPORTS and DISCUSSION</u>

A. HS Student Representative Report – Miss Paulina Karwowski and Mr. Sukhman Singh

AP Testing was May 7 to May 23, three days had to be changed due to the storm. The Next Generation Science Assessment was administered to juniors on May 21. The 16th Annual Awards night was held on May 24 and over \$96,000 was awarded to graduation seniors. One student walked away with our \$10,000 in scholarships! The Gesek Honor Roll Breakfast hosed by the Fathers Club was held on May 30; 30% of the student population were recognized for maintaining honors or above for the first three quarters of this school year. The Mr. Seymour Competition was held on May 31, Tom Herrick won the event with his many diverse talents. Judges were Mr. Wilson, Mrs. Stanek, Mr. DiStasi, Mrs. Sweeney, Mrs. Anelli, and Mr. Yak. Ms. Pinho organized the event, Mrs. Brown and Mr. Aprea co-hosted the evening, and Mrs. Federowicz added up the scores. The Board was happy to hear that Sukhman placed 3rd. The Senior Picnic was held on June 1 at Holiday Hill. The baseball team earned a trip to the Class M semifinals which will be held at Palmer Field in Middletown on June 5. The softball team lost their quarterfinal game to Granby on June 3. The team had an amazing season and there are three graduating seniors who will go on to play D1 softball.

B. Committee Reports

Curriculum and Technology Committee Meeting Minutes – May 21, 2018

Mr. Strumello reported it was a very fruitful meeting, however there is nothing being put forward to the full Board. He encouraged all BOE members to sit in on one of the Curriculum and Technology Committee meetings as this would be a good one to observe. Mr. Hatfield voice a concern about losing the Smart Boards. Mr. Strumello said it is not the intention of this committee to take any tools away from our teachers. Ms. Magri said she trusts that the staff will bring forth any recommendations.

C. Safety Shades Video – Mr. Rich Kearns

Mr. Kearns shared an example of the safety shades he wants to purchase for the district. These shades are endorsed by law enforcement as a proven way to keep classrooms secure in the event of an intrusion into a school. Once the shades are pulled down, it is impossible to see into the room. These shades cost \$9.00 to \$30.00 and are the easiest. most economical way to secure a classroom from sight. The shades operated by pulling a tab, the shade falls down and the bottom is secured to the window by Velcro. Mr. Kearns has been working with the company to secure some discounts for our district. They are offering a 10% discount because we are one of the first districts on the East Coast to purchase their product and another 10% if we will respond to them with why we like the shades. If we do a "commercial grade" commercial explaining why we like the shades, we can secure a 30% discount. Mr. Kearns said the total cost to the district will be \$2197. Mr. Kearns asked the Board for their approval to do a video in order to secure the 30% discount. He said Mr. Catanese has the equipment needed to produce this commercial. Mr. Kearns said he would not identify Seymour Public School but rather indicate we are one of the school districts in the Naugatuck Valley. Mr. Garofolo voiced some concerns about who would get credit, producer, actors, and narrator? Mr. Kearns said it is not like that when he refers to a "commercial grade commercial" he is referring to the quality of the commercial not an actual commercial. He asked who would narrate the commercial and Mr. Kearns said he would. Mr. Garofolo asked if people would be able to recognize him as part of Seymour. Mr. Belden said we have already had this happened, Mr. Dver has been quoted on certain products.

E. Spring MAP Assessment Data – Mrs. Vonda Tencza

Overall spring results showed positive trends in both math and reading, K-10. Dips in performance in specific grades will be examined. The district will continue to utilize the strategies of communicating clear learning targets and providing specific feedback next year, as well as working to conduct peer and group observations and study of the classrooms and grade levels which demonstrate tremendous success this year.

Chairman's Comments

Ms. Magri reiterated the support of the Board of Education to the high school drama and music program. She wanted to reassure the students and staff that the Board knows how important these programs are and the Board will continue to support them.

2. Board Member Comments

Mr. Stanek said he echoed Ms. Magri's comments and he is certain we will not go back to the days where no programs, plays or concerts existed.

H. Superintendent Report

1. PSAT Data – Tom Demers (093 Intern)

Mr. Wilson introduced Mr. Tom Demers, his 093 Intern. Mr. Demers gave a presentation on a comparative analysis of the PSAT and the SAT for Seymour. Mr. Demers noted to the Board the following highlights from his research:

Are PSAT and SAT strongly correlated?

Yes, the PSAT and SAT scores are strongly correlated

Is the PSAT a good predictor of student performance on the SAT?

Yes, correlation coefficient suggest SAT scores can be predicted based on PSAT performance

Do Seymour's scores follow National trends for PSAT/SAT scoring?

Town scores fall within the national average for growth over the past two senior classes for their PSAT and SAT performance

What steps can be taken to improve SAT scores before high school?

College Board has partnered with Khan Academy, an online learning resource for students in multiple subject areas. Students can link their College Board accounts with Khan Academy allowing for students to follow an individualized program to help improve scores on all areas of SAT

Early data shows that students who used Khan Academy for 20 hours of personalized SAT practice have 115 point average score gains.

Shorter practice periods of 6 to 8 hours correlated to a 90 point average increase.

Tom's research definitely was an eye opener for our secondary level Administrators. They will now keep an eye on our students' scores in order to ensure that we are making the necessary progress.

Ms. Magri asked our student representatives what their experience with Khan Academy is and Sukhman Singh replied it shows you what you missed and if you do what the program suggests your score will go up. He said his score went up dramatically. Paulina Karwowski said she had a similar experience and it did not take a lot of time. Mr. Singh said it only focuses on the help you need so you don't waste time doing things you already know. Dr. Hendricks said he really admires what they have done. Mr. Demers said students can take the test 8 or 9 times at no cost. Mr. Lucke informed the Board that a parent can sign in as a teacher in Khan Academy and actually assign their child assignments and monitor their progress. Ms. Magri said the summer newsletter should include this information. Khan Academy is a free service. Mr. Strumello asked how they make money. Ms. Harmeling replied they don't make money they are largely funded by the Gates Foundation

C. Chromebooks Purchase

Mr. Belden discussed the ongoing implementation of Chromebooks in the district and in this cycle we need to purchase 660 Chromebooks. After reviewing the quotes from three providers, it has been decided that SHI is the best provider for this acquisition. The 660 Chromebooks will finish off the needs of the middle school, provide for world language and math at the high school and provide some replacements at CLS. Warranties will continue under these leases. Mr. Kubik asked Mr. Belden to confirm these costs are annual not monthly as was reported on the handout. Mr. Belden confirmed these are annual costs.

Dr. Hendricks asked about the big difference in the cost of etching. Mr. Dyer said he thought the difference was due to the fact that SHI does their etching in-house. Mr. Dyer assured the Board that he has done business with SHI in the past and he comfortable using them. Mr. Hatfield wondered about going to 1-1 in the district and that this might afford us the opportunity to save money not having to buy carts. Mr. Dyer explained it's not that simple and many decisions would have to be made. Ms. Harmeling agreed. She asked about the replacement cost of carts and Mr. Dyer said they are very heavy duty and do not need to be replaced as often as computers.
