#### Item #9 - Report from the Finance Director

- Projection of year end expenses was \$1,598,784 less than actual
- Projection of year end revenues was \$1,663,062 less than actual
- Deficit of \$64,278
- Next year, we will get about \$529,000 more revenues from the state
- Doug needs to change the fund balance figure on the "Financial Summary" as \$4,000,000 (total) was transferred last month to the Debt Reserve Fund and the Internal Service Fund Reserve.
- Lease for street lighting \$496,000 was signed with Eversource; this money is currently in the Street
  Lighting budget, but we should move this money to the Debt Service (where the payments should come
  from)
  - Motion to move the value of the lease payments for 2018/2019 out of the Street Lighting Budget and into the "Debt Service – Street Lighting Lease"

- Jim Baldwin has been hired full time as Building Inspector; will generate more business & revenue for the town
- ECS Check came in \$10.1million; we expected \$9,525,000
- Bill Sawicki suggested that we get an ordinance developed and approved to bond for \$150,000 for the Town Building projects (police station, library, town hall) as there will probably be additional expenses. The police station building is about 100 years old and will have additional items come up; also, we will need to develop O & M manuals for all the new systems being installed. We have \$1.6million total already for these projects (\$1.5million + \$115,000 grant from the library). This will give us the authority to go out and get loans, bonds, etc. and not have to tap into the fund balance. This way we will have the cushion needed for any unforeseen expenses. If we don't end up needing the money, we can cancel the ordinance. Doug will look into this.
