ITEM #5: First Selectman's Report.

• Kurt discussed the budget he presented to the Board of Finance. The budget he presented will keep the mil rate at 36 for the third year in a row. The overall expenses of the town decreased .31%. We are running at \$172,979.00 less for FY 19 than we did for FY 18. Over the last 3 years, the increases to the overall town budget have been .6 in FY 17, .1 in FY 18 and -.31 in FY 19. With the \$2 million cut from the State of Connecticut, FY 20 and 21 will be a challenge. Kurt will be presenting to the board at the next meeting. He would like to set the unencumbered cash reserve at 12% and go through the Capital Plan.

ITEM #6: Awarding of bid for Citizens' Engine Co. No. 2 roof project.

Kurt read the following letter from Don Smith, Jr., Town Engineer, to the Permanent Building Committee:

Dear Committee members,

On February 22, 2018, the Town Received four (4) bids for the above referenced project prior to the specified closing time and on a fifth bid, one minute after the closing time, but prior to any bids being opened. After reviewing the bid language, Town Counsel opined that it was in the best interest of the Town to waive this informality in the bid submission and open the bid. See the attached Bid Tabulation sheet for a summary of the bids.

As indicated in the attached tabulation, the low bidder is A Preferred Construction, LLC.

We have reviewed the scope of work with the low bidder and the references they have furnished. Accordingly, it is our opinion that the Town's best interests would be served by awarding the above referenced Project to A Preferred Construction, LLC in the amount of \$76,100.00 (seventy-six thousand one hundred dollars) for the base bid only, subject to posting the necessary Bonds and Insurance certificates.

We trust this information allows the Committee to make an informed decision on this matter.

Al Bruno stated the Public Works budget is almost expended with all of the work they have been doing. The front of the Middle School looks great. They are proactive and will develop a plan to prioritize everything. The school safety seminar was very impressive. Rich Kerns is such a great asset for the Town of Seymour.

Annmarie Drugonis stated Rich Kerns is a blessing to this town. Public Works have been going around trimming trees and fixing pot holes.

Kurt discussed a new machine for pot holes that will be purchased for Public Works next year.

Trisha Danka stated she was really impressed with the attendance for the school safety seminar. It goes to show how members of the community are concerned about the safety of our children in our schools. She is glad that they are getting involved with the opioid retainer. The Pharmaceutical companies intents might not have been to create the epidemic we have throughout the nation but, their greed has really caused the tragedy.
