SPECIAL TOWN MEETING TUESDAY, OCTOBER 15, 2019  
AND REFERENDUM VOTE TUESDAY, NOVEMBER 5, 2019

The electors and those persons eligible to vote in town meetings of the Town of Seymour, Connecticut, are hereby warned and notified that a Special Town Meeting will be held at the Seymour Town Hall, 1 First Street, Seymour, Connecticut, on October 15, 2019 at 6:30 P.M. for the following purposes:

ITEM 1. To discuss a Resolution:

- (a) To appropriate \$5,000,000 for the reconstruction and repair of various Town roads and roadside elements, including associated drainage facilities;
- (b) To finance said appropriation by issuing bonds, notes, temporary notes or other obligations in an amount not to exceed \$5,000,000;
- (c) To authorize the First Selectman and Treasurer to determine the terms, details and particulars of the bonds, notes, temporary notes or other obligations;
- (d) To declare the Town's intent to finance the projects so that project costs may be temporarily advanced; and to authorize the First Selectman and Treasurer to enter into agreements and other documents on behalf of the Town for the projects and the financing of the projects; and
- (e) To authorize the First Selectman to apply for and accept or reject grants-in-aid for the projects, and to authorize the First Selectman to execute agreements and other documents on behalf of the Town for the projects and the financing of the projects.

A copy of the full text of the Resolution is on file and available for inspection at the Offices of the Town Clerk.

ITEM 2. To discuss a Resolution:

- (a) To appropriate \$1,500,000 for communications equipment for the Town's emergency services departments, including, but not limited to, the Town's Fire Department, Police Department and Emergency Management Department;
- (b) To finance said appropriation by issuing bonds, notes, temporary notes or other obligations in an amount not to exceed \$1,500,000;

- (c) To authorize the First Selectman and Treasurer to determine the terms, details and particulars of the bonds, notes, temporary notes or other obligations;
- (d) To declare the Town's intent to finance the projects so that project costs may be temporarily advanced; and to authorize the First Selectman and Treasurer to enter into agreements and other documents on behalf of the Town for the projects and the financing of the projects; and
- (e) To authorize the First Selectman to apply for and accept or reject grants-in-aid for the projects, and to authorize the First Selectman to execute agreements and other documents on behalf of the Town for the projects and the financing of the projects.

ITEM 3. To discuss a Resolution:

- (a) To appropriate \$15,000,000 for a new community center;
- (b) To finance said appropriation by issuing bonds, notes, temporary notes or other obligations or pursuant to a long-term lease agreement with a third party in an amount not to exceed \$15,000,000;
- (c) To authorize the First Selectman and Treasurer to determine the terms, details and particulars of the bonds, notes, temporary notes or other obligations;
- (d) To declare the Town's intent to finance the project so that project costs may be temporarily advanced; and to authorize the First Selectman and Treasurer to enter into agreements and other documents on behalf of the Town for the project and the financing of the project; and
- (e) To authorize the First Selectman to apply for and accept or reject grants-in-aid for the project, and to authorize the First Selectman to execute agreements and other documents on behalf of the Town for the project and the financing of the project.

The Moderator shall adjourn the Special Town Meeting at its conclusion and the Resolutions under Items 1, 2 and 3 above shall be submitted to a vote upon the voting tabulators or the ballot on Tuesday, November 5, 2019 between the hours of 6:00 A.M. and 8:00 P.M.

The Resolution under Item 1 above shall be placed upon the voting tabulators or the ballot under the following heading:

“SHALL THE TOWN OF SEYMOUR APPROPRIATE \$5,000,000 FOR THE RECONSTRUCTION AND REPAIR OF VARIOUS TOWN ROADS AND ROADSIDE ELEMENTS AND FINANCE THE APPROPRIATION BY ISSUING THE TOWN’S BONDS, NOTES, TEMPORARY NOTES OR OTHER OBLIGATIONS IN AN AMOUNT NOT TO EXCEED \$5,000,000?

The Resolution under Item 2 above shall be placed upon the voting tabulators or the ballot under the following heading:

“SHALL THE TOWN OF SEYMOUR APPROPRIATE \$1,500,000 FOR COMMUNICATIONS EQUIPMENT FOR THE TOWN’S EMERGENCY SERVICES DEPARTMENTS AND FINANCE THE APPROPRIATION BY ISSUING THE TOWN’S BONDS, NOTES, TEMPORARY NOTES OR OTHER OBLIGATIONS IN AN AMOUNT NOT TO EXCEED \$1,500,000?

The Resolution under Item 3 above shall be placed upon the voting tabulators or the ballot under the following heading:

“SHALL THE TOWN OF SEYMOUR APPROPRIATE \$15,000,000 FOR A NEW COMMUNITY CENTER AND FINANCE THE APPROPRIATION BY ISSUING THE TOWN’S BONDS, NOTES, TEMPORARY NOTES OR OTHER OBLIGATIONS OR PURSUANT TO A LONG-TERM LEASE AGREEMENT WITH A THIRD PARTY IN AN AMOUNT NOT TO EXCEED \$15,000,000?
