Chris Edwards/Al Rochelle made a motion to add Fire Police to the agenda. Vote: 3/0

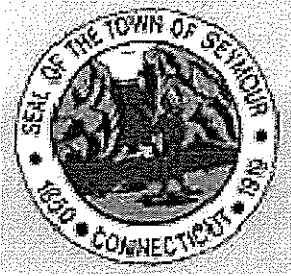
