Maintenance & Operations

Curb replacement and ADA improvements along Willow Oak Avenue in Bear Trap Dunes have been completed. Any areas that were seeded and the seed did not germinate will be re-seeded this fall.

Drainage repairs and pipe cleaning were performed in the Avon Park Community.

Bicycle and Pedestrian Safety Initiatives

The Advance Warning signing and pavement marking plans for cyclists have been reviewed and approved by DelDOT.

Traffic counts to capture peak summer volume will resume in Ocean Way Estates the last week of July.

Planning and Development received \$35,000.00 for several traffic safety initiatives. Attached for your information is the memorandum detailing each initiative and the associated costs. The bicycle safety effort along SR 26 has been deferred to next summer due to the unknown situation with COVID-19. However, the experimental warning signs have been installed prior to five unsignalized intersections along SR 26 which include Old School Lane, Woodland Avenue, 29 Atlantic Avenue, Tyler Drive, Town Road and Ocean Mist Drive. This work was completed prior to the July 4th holiday. The painting of the Bike Lane will take place this September.

The study to deter cut-through traffic along the north side of town has been completed. Data analysis and recommendations for improvements will come later this year.

Capital Projects

The project to construct sidewalks and drainage improvements along the east side of West Avenue from SR 26 to William Avenue has been designed to 60% completion. We will begin reaching out to key stakeholders to discuss these plans.

Land Use and Development Issues

The Stingray Harbor project continues to progress. Water, sewer, and drainage infrastructure has been installed. The contractor began to install curb the week of July 6th and paving is expected to take place the week of July 14th.

As of this date, the Town has not received receipt of the Certified Letter delivery for the Property Maintenance Violation.
