FOR THE SEPTEMBER 2018 TOWN COUNCIL MEETING

- Chief McLaughlin met with Lauren Weaver of the Chamber of Commerce in order to discuss plans for a business outreach event.
- Chief McLaughlin and Officer Carter met with officials from Verizon regarding disruptions to police applications due to poor cell service.
- Speed Trailer deployed in multiple locations.
- Correspondence sent to US Postal Service in support of Town's request to change the ZIP Code for the Tidalwalk Development.
- Correspondence with DelDOT reference Traffic Engineering Study on Muddy Neck Road.
- Chief McLaughlin attended several meeting of the Southern Sussex Ministerium. The focus of the meeting was to establish a Homeless Shelter in the Bethany/Ocean View area.
- Chief McLaughlin and OFC. Bowden attended a candlelight vigil in Georgetown sponsored by Attack Addiction.
- Updates to the Town's Emergency Operations Plan were initiated in August.
- Met with emergency management officials reference up-coming Full-Scale Exercise scheduled for October 14th at the Ocean View Church of Christ.
- Applied for and received \$4,730.10 in state assistance from the Office of Highway Safety. The funds were used to purchase RADAR and LIDAR speed measuring devices to assist in addressing speed related complaints.
- Validations were done on criminal warrant files.
- Completed grant application and received \$1000 from the Atlantic Community Thrift Shop. Funds are being used to enhance existing police video camera equipment.
