- The police department received a \$20,500 grant from the Criminal Justice Council. The funds will be used to purchase supplies and cover overtime costs during the COVID 19 pandemic.

- The police department investigated two fatal drug overdoses in the past 30 days. Police continue to focus on curtailing drug sales in the community.
- The Beebe southern campus on Rt.17 is open. Police have made use of the facility on several occasions.
- Police staff requested and received PPE gear from the Delaware Department of Homeland Security.
- Mr. Connor Watkins of Millsboro, DE was hired to fill the new police officer position. Connor holds an AA Degree in Criminal Justice from Delaware Tech and is currently working towards a degree in Psychology at Wilmington University. He is scheduled to begin police academy training on June 24<sup>th</sup> in New Castle County.
