- Police recruit Connor Watkins began training at the New Castle County Police Academy on June 24th.
- As mentioned in previous reports, the police department received \$5,720 from the Office of Highway Safety (OHS). The funds are earmarked for overtime assignments focusing on bicycle and pedestrian safety. The initiative includes two weekly blocks of overtime (4 hours each). Officers working the overtime target bicycle and pedestrian violations and motor vehicle violations which endanger pedestrians and bicyclists. The initiative also includes a bike safety checkpoint, which is scheduled to take place on Wednesday, July 15th between 6pm-10pm.
- A seasonal police dispatcher is manning the police reception desk between the hours of 8am-4pm on Saturday and Sundays.
- Chief McLaughlin and Sergeant Bradshaw assisted the Firearms Training Unit with training recruits at the Delaware State Police Academy.
- The police department responded to numerous complaints regarding speeding on town roadways. A total of 155 speeding tickets were issued.
