1. ACTIVITIES:

- 1.1 The Board held one public hearing on Sept 7, 2013 involving 14 automobile appeals.
- 1.4 Of the 14 appeals, the Board reduced the assessment on all 14 appeals.

- 2.1 ASSESSMENT ADJUSTMENT: The Board's adjustments totaled \$ (32,630) (see attached).

3. COMMENTS:

This year was the largest number of automobile appeals in many years. Auto assessments were unaffected by the revaluation and coupled with the mill rate increase, the tax on autos increased by 4.49 mills, without any increase/ decrease in value.
