- 5. DISCUSSION
  - A) DEEP grant awards: James Ventres reported that there has been no word on the recent state grant submittals.
  - B) Property reports:

Zeiller and Pages Properties – Reimbursements have been received for these properties.

Harris Property - Final paper work has been submitted to the State DEEP.

Dean Property – The state has expressed the desire to use their version of the conservation easement. A copy was forwarded to Peter Dean and His family to review.

Trowbridge Road Property – James Ventres presented a proposal from a property owner on Trowbridge Road in which he would like to exchange 20,000 sq/ft of property with the town. The exchange would allow him to have a squared up piece of property and the town would benefit in the following three ways:

- 1. The exchange would allow access from Trowbridge Road to the east side of the middle school property.
- 2. The buses would be able to have a proper turn around at the town line.
- 3. An ancient foundation would be part of the town property.

After discussion, the committee agreed that it would be a beneficial exchange.
