To Board of Finance members,

I am sending this email as I cannot be at the public hearing tonight due to the conflict with the High School Underclassman Awards Ceremony.

I am asking that you revisit the additional \$100,000 decrease to be made to the BOE budget at the next referendum and look very closely at how that decrease could effect this town for years to come. Despite the rocky road our schools have been on for the past year or so there are many very good things going on in this district. My son is a Junior and has received an excellent education here. But will the same be true for my daughter who is in 7th grade? Program, teacher and administrative cuts lead to less and less opportunities for our children. We could lose some of our best teachers with further cuts. And despite wishing it were so, education is not the same as it was years ago, much more is expected of children at all ages. No longer is a basic education enough to be successful. If East Haddam Schools cannot offer its students the tools necessary to compete at a high level with students from around the country, parents will look for those opportunities elsewhere. They have already begun doing this. And it is many of the best and brightest students leaving our schools. When they pick a magnet school to attend instead of one of ours it is a double whammy as we have to pay for them to go out of district. This begins a downward spiral of children leaving, less enrollment, more cuts because of lower enrollment, more students leave because of less offerings, and so forth. Parents of children who leave the district are also lost as active members of our town, often some of our best volunteers. It is the schools that bind so many of our citizens. It is actually scary for me to think of where this will eventually lead.

I voted yes at the last referendum, but did not do so happily. The BOE budget was too low in my opinion. A group of parents and I usually work to get the vote out but many of us were too confused and upset by the whole process to offer a strong opinion one way or the other. I can say that if the budget goes back to referendum at the original amount many of us will work to get the yes vote out this time around. We have had time to cool off and look at the big picture. I can't guess what will happen if the BOE side is cut \$100,000 while the town side remains the same, which does not seem to support the exit poll, but whether it passes or doesn't pass at that level, the kids are the ones who are hurt the most. They are our future leaders, we need to do what we can to make them the best they can be; further cuts will not give them enough support for this to happen.

In closing I have forwarded a letter to the BOE from Denise Gable regarding the current 8th grade team at the Middle School. It is experiences like these I fear will disappear with continued cuts to the BOE budget.

I wanted to share an amazing experience my daughter (8th Grade at NHRMS) has been given by the 8th Grade Teaching Team.

For the past few weeks, the 8th graders have been visited by three Holocaust survivors and one World War II veteran. The stories these remarkable people have shared have been one of the most enriching learning experiences she has has ever had. Before I had a chance to ask how her day was, she had gone into a lively and detailed account of their presentations. At the dinner table she relayed their stories to us, including Mrs. Fishman's experiences in the ghetto, as a political prisoner in a concentration camp, and of her infamous babysitter – Anne Frank! Last week, Ben, a World War II veteran shared his emotional stories of liberating the Jews and of his friendship with one of the holocaust survivors. I cannot begin to express how these speakers have affected my daughter. The opportunity to hear their stories firsthand has stayed with her more than any textbook or lesson could. I am so thankful to this team of teachers (Danielle Michaud, Jillian Palmer, Melissa Luke, Robert Raines, Shaleen Thody, and Lisa Plante) for working so hard to provide these speakers – I know these stories will stay with her for a lifetime...

...this got me to thinking about the budget and some of the recent discussions at the BOE and BOF meetings. The heart and soul of these schools are the people who work there. Every decision made – such as sending blanket non-renewals – affects these individuals who are working their tails off to provide our kids with the best possible educational experience possible. Please keep this in mind when making choices – it goes without saying that every decision is difficult when facing budget cuts. But please don't forget that all these positions have names and faces – they are not numbers, they are responsible for our kid's future.

As most of you are aware, the Budget Referendum held last week on Thurs, May 20 failed. Votes were cast as follows:

Yes- 434

No- 494

for a total of 928 votes. Thanks goes to all who turned out to vote!!

Exit polls were conducted as well. The results of the poll are as follows:

BoE:

acceptable - 74 too high - 112 too low - 112

General Government: acceptable - 142 too high - 110 too low - 26

The question I was asked was this: How can BoF justify cutting another \$100K from the education budget with numbers like these?

My reply was as follows:

BoF made their decision by considering the following:

a. the budget not passing and

b. as many people stating that the BoE budget was too high as said it was too low.

The BoF made it abundantly clear prior to the Referendum that if the budget did not pass and if the exit poll did not clearly indicate that the BoE budget was too low, then they would cut from BoE. I sincerely wish more people had taken time to fill out the exit poll!

I can not vote (being Canadian), however, if I was able I would have voted YES for this budget. While I have entirely different views on what the reductions should be on the BoE side of the budget, I did not want to see further cuts be made to education. I feel that my views on how the education funds should be spent is a completely different issue from how much the education budget is. And, taking into consideration the fact that the education side of the budget has seen relatively generous increases for the past 4 years I felt that the BoF was being reasonable. My argument with BoE should be fought separately from my decision on the BoF budget.

Unfortunately, I can not attend the Public Hearing since the HS award night is also tom evening. However, I will send my thoughts to both BoE and BoF and I hope you will join me in doing the same!
