Minutes were read and reviewed and accepted.

Attendees discussed the Ag Ad Hoc field trip to Rosedale Farm in Simsbury, CT. This farm is considered to be the only actual HUB type farm in CT according to Kip Solinskas of the Farm Trust. This unique farm was in the Epstein family for years and is now part of a Simsbury land easement with the Simsbury Land Trust. It was decided to discuss the farm at the next Agriculture meeting so Ag Commissioners could benefit from the information learned.

Linda attended a 5 hour session at the Extension Center regarding the new FOOD SAFTEY MODERNIZATION ACT that was passed by Congress in 2011 and introduced by Rosa Delora in 2009. While this extensive Food Safety ACT is now law, it is currently under the RULES phase which will end on November 16, 2013. Several heads of Agriculture Departments in the State of CT were present and spoke to a crowd of approximately 200 farmers. The Department heads were most concerned about this new law and how it would strongly affect the welfare of farmers and farming/processing programs. Farmers voiced their concerns and were likewise distressed. Linda spoke with Diane Hirsh, R. D., M.P.H., Cooperative Extension Educator Foods, Nutrition, and Food Safety, following the informational meeting. Ms. Hirsh suggested she visit the East Haddam Agriculture Commission and discuss how this law will affect the processing and farming project. Ms Hirsh suggested she and Mr. Bonelli could visit and discuss pertinent information on Food Safety and Risk Management planning. Linda obtained a copy of the power point presentation that afternoon and emailed it to the Selectman and all Ag members to review.

A reservation was secured for Ag Commission to visit Greenview Mass, Franklin County Community Development Center, (<a href="http://www.fccdc.org">http://www.fccdc.org</a>) on Wednesday December 4, 2013. Dates for White Gate Farm, (<a href="http://whitegatefarm.net/whyorganic.php">http://whitegatefarm.net/whyorganic.php</a>) and Massaro Farm (<a href="http://www.massarofarm.org/wp/learning/">http://www.massarofarm.org/wp/learning/</a>) visits are in discussion.

AD HOC attendees discussed the positive progress made to date with the business plan development. The Business Plan Summary, Mission Statement, Goals, is being finalized. Home research on Regulations, Marketing and field visits is performed each week.

The following are the drafted FOUR GOALS for the Business Plan.

- A REGIONAL INCUBATOR TO GROW AGRICULTURE RELATED JOBS AND BUSINESS IN THE COMMUNITY.
- TO PROVIDE A CERTIFIED KITCHEN FOR PROCESSING AND OTHER, THAT WILL BE RENTED FOR COMMUNITY USE AND IS FEE BASED.
- TO SUPPORT NEW AND YOUNG FARMERS THROUGH AGRICULTURE RELATED EDUCATION AND FARM DEVELOPMENT.
- TO PROVIDE LAND AND AGRICULTURAL SERVICES TO FACILITATE AGRICULTURE GROWTH.

AD HOC members further discussed preliminary short-term job related possibilities and how the kitchen will produce jobs. Questions to be defined:

What will they produce?

What kind(s) of processing?

Will kitchen be strictly organic or open to traditional processing and use?
