# East Haddam Conservation Commission Forestry and Stewardship Sub-committee

February 17, 2016 Adopted March 3, 2016

### 1. Call to Order

The Special Meeting of the Forestry and Stewardship sub-committee of the East Haddam Conservation Commission was held on Wednesday, February 17, 2016, at 7:05 PM at Todd and Charlotte Gelston's residence on Bogel Road. The Chairperson being in the Chair and the Secretary being Present.

## 2. Approval of Agenda

Motion by Ms. Gelston to approve the agenda as presented. Second by Ms. Gleeson and unanimously approved.

#### 3. Old Business

a. Reprints and new prints of the trail guide

At the 2 turnstile map holders in town, there are still maps for Ayers, Ballahack, Burnham, Rose Farm and Urbanik. There are no copies of Olde Field in the holders. Ms. Gelston has the following maps in reserve:

Given the EDC's commitment to paying for a reprinting, Mr. Gelston will reach out to Mr. Casner, chair of the EDC, that the printing will be done and thus a bill will be provided end of March/early April.

Ms. Gleeson will talk with Ms. Snow in the Town Office to order 20 more map holders. Mr. Zaid has 8 map holders of which 2 are going to be installed shortly, leaving 6.

# c. Recycle Signs

Ms. Gleeson noted that wherever a map holder is installed, a recycle sign is posted as well.

## d. Projects and Project Schedule

Mr. Gelston provided a Conservation Commission Stewardship Project Priority list, and reviewed it with the group. Mr. Gelston asked the group to talk through what priorities should be shifted. The group discussed moving Chapal Farm up from 7. on the list to the first priority. There is a need to get kiosks built. A large map needs to be ordered. Mr. Gelston will talk with Mr. Smith to discuss when the survey will be completed. The second priority will be Sabine, with the bridge being moved and trail upgrades. The third priority is Davison, which needs a kiosk and clearing the vista. The fourth is Lena – blaze boundaries and create parking lot. The fifth is Roaring Brook – tag and blaze boundaries. The sixth is Harris, to address the Guggenheim property boundary marking, install a small bridge, map holders, kiosks and two parking lots. The seventh is Dean which needs parking. The eighth is Rose Farm, which needs some tree work and the southern boundary marked along with a foot bridge. The ninth is Zeleznicky, and tenth is Lefebvre.

## e. Saturday Work Afternoon Tasks and Schedule

The schedule is every 2 weeks and if there's a cancellation, the work party will not be rescheduled but will wait until the next scheduled party.

## f. Davison Vista Swath Cutting

This Saturday, a wood cutter will review the Davison property to see what the cutting will cost and if it is feasible.

Mr. Zaid and Mr. Sienna provided to Mr. Gelston, who will provide to Mr. Smith.
