Regular Meeting Minutes February 28, 2017

3. MINUTES

The commission voted unanimously to approve the January 24, 2017 meeting minutes as amended.

6. LOT LINE REVISION

a. #16-24 - Winthrop & Carolyn Guptill, 29 Daniels Road, lot line revision. Assessor's Map 37, Lot 72 & 73.

Mr. Ventres explained the revision would change the acreage of the lots. Lot line revisions would allow for a 7.9 acre lot and a 47 acre lot. Each lot will have a house, barn, septic, and well.

Mr. Ventres read into the record a letter from the Chatham Health District dated November 26, 2013, granting approval for the revision.



Motion by Mr. Curtin to approve application #16-24 – Winthrop & Carolyn Guptill, 29 Daniels Road, lot line revision. Seconded by Mr. Salicrup and unanimously passed.

7. REVIEW OF THE PLAN OF CONSERVATION AND DEVELOPMENT

Mr. Ventres reviewed the following:

- -Letter from Robert Casner, Chairman of The East Haddam Economic Development Commission, dated February 21, 2017. Mr. Ventres read the letter into the record. Mr. Casner recommends hiring an outside consultant.
- -Appendix I 1997 & 2006 Public Opinion Survey Summary.
- -Conservation & Development Policies: The Plan for Connecticut 2013-2018.
- -Plan of Conservation and Development Survey's from various towns.

Mr. Thomas noted the budgetary constraints of hiring an outside consultant. Mr. Ventres stated the Board of Selectman had advised him that there was no funding in the long range plan for a consultant. Mr. Pettinelli suggested researching local universities for a graduate student majoring in Urban Planning.

The commission will develop a new Public Opinion Survey. Mr. Pettinelli suggested adding economic development questions.

The Plan of Conservation and Development will need to be complete for town approval in August of 2018.

There was a brief recess.

Commission members reviewed and discussed draft Trailer and RV Regulations.

Commission members voiced concern that changes to the regulations would create new violations.

Mr. Ventres will ask the town attorney to review the regulations.
