# Town of East Haddam Firehouse Renovation Building Committee September 6, 2017 Adopted September 20, 2017

#### 1. CALL TO ORDER

The Regular Meeting of the East Haddam Firehouse Renovation Building Committee was held on Wednesday September 6, 2017 at 7:00 p.m. at the Company #2 Firehouse.

## 3. Approval of Meeting Minutes from the regular meeting dated August 16, 2017.

#### 4. New Business

#### A. Moodus Firehouse #2 project

Committee members reviewed Architectural Drawings. The Building Inspector, Chatham Health and the Land Use Office are reviewing them. These drawings are filed at the Selectman's Office.

The contractor confirmed the thermostats were in the best locations on the architectural drawings. Mr. Dutch will provide the contractor with specifications to tie the heating units into one thermostat for project cost savings. Mr. Dutch suggested that the new bay additions be heated to just above freezing. Mr. Dutch stated it would not be necessary to have two propane heaters if it wasn't necessary to maintain a constant 65 to 70 degrees in the new bays. This would be a credit to the project. Mr. Donovan will be asked to provide a quote this value engineering item.

Vehicle parking locations will need to be reviewed to accommodate the location of the vehicle exhaust and heated space.

It was decided not to repair the exterior building panels.

Mr. Donovan will be asked to provide a project schedule.

Mrs. Varrichio will verify with the Town Attorney if value engineering can be a part of the interview process. She will review if there are any wage and hour issues with the top three bidders.

Mr. Fellner will provide value engineering items and interview questions at the next meeting.
