New Business

1. Meeting Dates – July, Aug, Oct

Ms. Quinn advised that the July and August meetings conflict with the Music on the River schedule. The Commissioners agreed to revisit this agenda item when it is closer to those meeting dates and make a decision on whether to re-locate, reschedule, or cancel the July and August meetings. 1. Budget 2017-2018 -

Ms. Quinn distributed copies of the draft 2017-2018 budget and the Commissioners discussed the changes in the proposed budget.

In response to a request by Ms. Quinn, Mr. Laffan agreed to provide pictures of the disc golf course for the Facilities Director to present to the Board of Selectmen when he requests additional funds for benches and scorecards. He also advised that a very complimentary comment about the course was posted on its Facebook page.

Ms. Francese recommended that the narrative section should include a reference to the number of individuals the Director interacts with and who are impacted by the Rec programs

Ms. Quinn reported that she met with the new president of the Soccer Club and they discussed duplication of efforts. She said they agreed that Soccer Club will recruit 3rd graders and older and the Rec Commission will continue the program for the younger groups. The Commissioners discussed the change and were unanimous in their support.

Ms. Quinn advised that she has retained the services of a facilitator for the Rec Commission's SWAT analysis who will assist with implementing the project over the next several meetings.
