A. **Silver Petrucelli & Associates**-Discussions occurred during Downes Construction's presentation.

B. Downes Construction

Mr. Scholl reviewed the following:

-Downes Building Committee Agenda dated 11/8/18.

Ms. Palmieri and Mr. Eldrige reviewed the Silver/Petrucelli Directive for Sequence of Operation for the Town Hall HVAC Systems dated October 23, 2018.

• The HVAC system is sequencing correctly and humidity has been removed from the building. Additional humidity testing will be performed after the winter months.

- Basement dehumidifiers will not be installed at this time. The committee will review again once into the cooling season and the current updated sequence is evaluated.
- The vault humidity has been reduced to 50% with a temporary dehumidification unit. Mr. Blaschik asked if the temporary unit could be removed from the space. Ms. Palmieri replied yes. Removal of the excess humidity will now allow for the Town Hall HVAC System to work properly. It was noted that the building had contained excessive humidity from being vacant for so many years and that the HVAC system was well equipped to keep humidity levels at 60% once excessive humidity had been removed.
- Repair and/ or replacement of the floor in the corridors for the Hale Building will be addressed once all humidity issues have been resolved.
- Corrective work has been completed at the front and rear sidewalks. The handicap stall correction is anticipated to start Thanksgiving week.
- Door pulls and closures are being repaired and a letter will be provided by Downes to Silver Petrucelli noting compliance.
- Mr. Stein will provide specifications for automating the front door.

The Owners Subcommittee did not review the change orders.
