The garden has been expanded this year, with help from a \$250 grant from the Rockfall Foundation. # B. Grass Roots Environment Fund Grant/Reusable Bag Project update

Yvonne Rubin reported that the bags have been delivered and are for sale at the Grist Mill Market, Nathan Hale Pharmacy, and the gift shop at Gillette Castle. The bags, which cost 97 cents each, were sold to the businesses for \$1 each, which covered the cost plus shipping. The money will be put back into the bag fund and used to purchase more bags. There are less than 100 bags left; there is \$500 in the budget. The bags may be sold at the Lions Club Auction on July 10. Patti Deschaine, publisher of the Fishwrapper, is interested in publishing an article on the bags, Martha Hansen will contact her.
