1. Call Meeting to Order – Mayor Vincent Festa called the Special Town Council with Board of Finance and Board of Education joint meeting to order on Monday, April 11, 2011 in the Cafeteria at Terryville High School, 33 North Harwinton Avenue, Terryville at 9:20 p.m. There is a quorum present of Town Council with only excused absence of Councilman Wunsch.

Mayor Festa stated on behalf of Council thank you to the Board of Education and Board of Finance of job done in presenting this budget and all the time they and Dave spent on figures and do not remember a better time than have had this year to present budget with common sense and what it does for the community.
